

Annual Meeting Minutes

January 26, 2014

Moderator Annie Anderson called the meeting to order at 1:00 pm after a delicious potluck dinner. The agenda was reviewed. Cyndi Leinberger moved to accept the agenda and Jeannie Reeves seconded. The motion passed and carried.

14 members were present so a quorum was established.

The Annual Meeting Minutes of the January 20, 2013 were reviewed. Cindy Price moved that they be accepted as reviewed. Jean Kees seconded and the motion passed and carried.

The Resumed Annual Meeting Minutes of March 17, 2013 were reviewed as well as the Special Called Congregational Meeting to make changes to the Church By-laws concerning the number of people needed to have a quorum. This meeting changed the quorum to be 30% of the active membership. Sue moved that both these minutes be approved. Cyndi Leinberger seconded. The motion passed and carried.

Pastors Report: Pastor talked about his being our interim pastor for three years. He has gone through a lot in his personal life this past year. He doesn't want to suddenly have to leave us. He wants us to plan ahead because he won't be able to be here forever. He asked us to think about what kind of church we'd like to be down the road? Churches need renewal- more young people. Pastor handed out paper and pencils. He asked us to write a "headline" for an editorial and the first paragraph of that editorial on how our church will be in five years. Pastor also asked us about any concerns or comments. Cindy Price said that she really appreciates Pastor's challenging sermons and challenges for each of us individually. Annie said that she appreciates that he has kept coming back to help us. Pastor said that he enjoys being here but is concerned about our future.

The following reports were reviewed:

Moderator's Report: A correction was made to the length of Bible School- it was three days rather than two...

Clerk's Report: No changes.

Steward's Report: There were no changes.

Board of Trustee's Report: There were no changes to the report.

Sue moved that the above four reports be accepted with the change to the Moderator's Report. Jeannie Reeves seconded and the motion passed and carried.

Women's Fellowship: No change to report.

Music Report: No change to the report.

Christian Education: No changes to the report.

Memorial Committee: No change to the report.

Sylvia moved that the above reports be accepted as presented. Jeannie Reeves seconded and the motion passed and carried.

Treasurer's Report: Sue reviewed the Treasurer's Report in the Annual Report. Jevon moved to accept the report as presented. Doris seconded and the motion passed and carried.

Sue explained the proposed 2014 budget. In 2013, we actually had a profit- we were in the black by \$1853.40! We are planning that the income in 2014 will be about \$51,425 and expenses will be about \$54,446.00.

Jevon thanked Sue for all her work as Treasurer for so many years. Everyone agreed.

Cindy Price moved that we accept the 2014 proposed budget as presented. Jevon seconded. The motion passed and carried.

The investment activity report was also reviewed as part of the Treasurer's Report. It looks good.

Nancy mentioned that the flower bed in Mother's Park is always in need of upkeep but with lots of help it is a centerpiece.

There was no Old Business and no New Business

Nominating Committee: Annie reviewed the Nominating Committee Report. Cindy Price will be Moderator in 2014. Julia Cox will be Moderator Elect. Monica Klingler will be Clerk. Sue Bellotti will be Treasurer. Cyndi Leinberger, Ann Anderson, and Bob Causey will be Trustees. There is one open position for Trustees. Jevon volunteered to fill that position. Sylvia Spangler, Edith Ann Power and Julia Cox are Stewards. They have one open positon. Jeannie Reeves volunteered to help even though she just finished a term with the Stewards. Sue Bellotti will continue to be the Christian Education and Music Director Leader. Someone is still needed to help with the Pastor Parish Relations and Memorial Committees. Nancy Karlson said she would help with the Memorial Committee. The Pastor Parish Committee is still in need of help.

Cyndi Leinberger moved to accept the nominations and Doris seconded. The motion passed and carried.

CHURCH MEMBERSHIP:

- ❖ We have 26 members who are active in our church.

- ❖ Many friends went to be with our Lord, this year, from our community. Sammy Weimer, Danny Nichols, Clancy Nichols, Wes Hawkins, Teresa White, and Betty Ruth Wallace. The Women's Fellowship provided meals and service for several families throughout the year.
- ❖ There was one birth among our members- Tage Murphy is Brett and Shannon Murphy's new son.
- There were no baptisms.
- There were no marriages in the church this year.

CHURCH ACTIVITIES:

- A Pastor Gary Bryant has graciously continued supplying part-time ministry during the past year, even amidst family hardships. Thank you Gary. We pray for you and all your family- that God will bless each of you with good health and help you through all your trials.
- ❖ Doris Achenbach continues to put together the monthly "Mustard Seed" to send out news about our church to those who cannot attend. It is always good to read. Thank you Doris and all contributers!
- Collbran Congregational Church held a very busy and well-attended Vacation Bible School in June (thanks to Sue Bellotti and Edith Ann Power and many others!). 25 -35 children attended.
- The Children's Sunday School has been faithfully and selflessly taught by Sue Bellotti and Edith Ann Power. 2-10 children have attended during the past year.

Most of those 47 years have been fulltime ministry, but a modest fraction have been part-time, including the nearly 5 total and delightful years I have spent with you – the good folk of Collbran Congregational UCC.

2014 was, in certain respects a repeat of 2013, in that you were so gracious to accommodate my desire/need to be with Leticia and her family while she underwent treatment for her inflammatory breast cancer. I am delighted to say that she is doing quite well, as is Linda's mother who now lives with us on a permanent basis.

I am ever so grateful to all of you for this part-time ministry opportunity. I feel that I receive more from you than you receive me, but I don't know how to measure any of that meaningfully. I do know that we engaged in serious team work, and I could not do even the small part that I do without amazing and gracious service from all of you. It is risky to begin naming names of those who serve us and support me in my ministry among you, but I will take that risk. **Thank you**...,

- Sue & Annie for musical contributions to our weekly worship and special events;
- Nancy for her quiet service of care for our building and for the leadership of such special events as the Senior Tea, Community Thanksgiving Dinner and numerous community outreach and mission projects;

- Edith Ann who makes sure we have a worship bulletin each week and who, along with Julia, assists Sue with our thriving Sunday School program;
- Sue, again, for her incredible commitment to the children of our congregation and to the children of our community through Vacation Bible School. I know there are many persons who make our Summer VBS program so much fun and successful, and I hope you know how much you are appreciate, even if I don't name all of you in this report.
- Cindy and members of the Church Council who provide outstanding leadership. There may be defined roles like Trustees, Stewards, etc. but everyone pitches in as needed to care for the building and its resources and our community life.

We have WiFi in the church, thanks to Sue's dedication.

AudioVisual equipment is used weekly for services (Sunday School and church).

Christian Education is active, and Sunday School and VBS are enjoyed by several youngsters. The annual fundraiser supporting these programs is popular and well attended. Thanks to Sue Bellotti and Edith Ann Power for your parts in this success.

Trustees/Council are considering a work-over of the kitchen to make it meet "commercial kitchen" standards. More member and community use of this area would be a good addition.

We welcome new people into our midst, are so glad when they return again, and we love when they continue coming.

Prior to church, every week, Neta posts our hymns so we can locate the next song we will sing before having to scramble to find it as Sue and Annie play the introduction.

The Board of Stewards juggles support for worship activities and supports church meals and gatherings. That doesn't take up much room in a sentence, but it takes a lot of dedication from these people to make sure greeters, ushers, and candle lighters are available every Sunday of the year, and to set up Communion so that when the pastor says, "Come, for all things are ready", they are.

The church and parsonage buildings and grounds require regular and ongoing attention and upkeep. Trustees work with the Council and Treasurer to manage the financial support for these repairs and updates.

Women's Fellowship is active and supports several missions through the church.

Senior Tea is an afternoon dedicated to honoring and celebrating the local high schools' seniors prior to graduation (Plateau Valley High School, and Grand Mesa High School), and their parents and grand-parents.

Turkey Dinner prior to Thanksgiving brings community people together for fellowship and a grand meal.

Health Kits are assembled and delivered to the Rescue Mission to support homeless and people who are just down on their luck.

Newborn Layettes are assembled and delivered to St. Mary's to support mothers in need of a boost in dressing and caring for their newborn baby.

Additional funds are added to the Church treasury, annually, to help pay for utilities and general expenses.

Nancy keeps the bulletin board updated with new announcements, outside the front of the church.

Thanks to Nancy Karlson for your constant dedication through the years, in monitoring the church property, use and scheduling, and for lining us out for "Cleaning Day". Thank you, for your dedication in making sure the building is clean and ready for events. Thank you for helping others in the community earn a little extra cash, as you orchestrate their help in maintenance of the church. Thanks for managing the Food Bank. Thank you Nancy!

We have an aging population and are without substantial middle-age and young adults. This is a larger concern than the short sentence indicates. Efforts and brainstorming for attracting these members to share worship are ongoing.

TREASURER'S REPORT 2014

The Collbran Congregational Church, UCC, successfully met the bills, salary, and maintenance expenses of 2014.

Additional expenses were incurred with large repair and maintenance projects at the church and parsonage. Insurance payments totaling \$18,669.71 went to pay for damage from ice and water in 2013. After a lengthy delay in receiving the bill from Belfor, who supervised the repairs, full payment in the amount of \$22,039.40 was made in September of 2014.

\$3,000.00 was drawn from our investment fund with UCFund to cover the remaining expense of these repairs.

In the spring, Terry Brown, was hired to make repairs to the church and parsonage. Pastor Gary made room for him at the parsonage during the week so we did not incur travel expenses as Terry Brown worked for several weeks with us.

Total cost of repairs to the church and parsonage were \$ 11,928.88. The trustees report lists many of the major repairs that were made. \$10,000.00 was drawn from the investment fund to help cover these repairs. The church members covered the additional \$1928.88.

The December 31, 2014 balance in the UCFund Investment account is \$228,977.29. With the strong stock market this past year we have grown well over the initial investment of \$210,000.00, which is the amount given to the church in the Collins and Hall bequests. Growth from the original funds is for the use of the church as needed.

We will continue to be prudent with the management of the funds received from each of you, who so generously and consistently support this church. In-kind donations continue to help keep our spending for everything from office supplies, cleaning supplies, paper goods, and craft materials in check.

I thank each of you for your financial support and your time and energy. It is the people that make the church. The building is simply the place we meet.

TRUSTEE'S REPORT 2014

Lawn care and snow removal has been provided by Delbert Koehn at both the church and parsonage.

This year wrapped up repairs on the church from the water damage reported in 2013.

Total received from the Insurance \$ 18669.71 Total Expenditures \$22,039.40

Advance from UCFund \$3000.00. The balance was met by the church members .

Other repairs made at the church were:

Removal of ice blocks from west valley of roof to prevent additional ice buildup during the winter.

Screws were tightened along the lower west roof while gutters were cleaned and secured.

Kitchen door was reset with new jam, primed, painted, and additional weather strip added to keep bugs and drafts out.

All windows and doors were scraped, primed and painted. All porches were cleaned and re-stained.

Plex-glass was removed from stained glass windows, the windows were cleaned, trim was repaired, primed, and painted before the plexiglass was cleaned and replaced.

Ease basement entrance was repaired and walls, ceilings, and floor were primed and painted.

Toilets were repaired. The ceiling in the overflow room was repaired and the room painted.

The Spirea was trimmed around the building and a rogue elm that had come up near the Gym entrance was cut down and the stump poisoned. Additional pruning is planned in the park in Spring.

Repairs made at the Parsonage began with the removal of the concrete patio on the west side that had broken and fallen away. The wooden pergola was removed during construction and repaired and stained before being installed over a new wooden deck which was built to replace the concrete slab. The backdoor was reset so it would open and close and interior repairs were made in the bathroom.

The stucco was repaired and the exterior of the house painted. The color was not changed.

Projects proposed for 2015 include new landscaping in front of the Parsonage and installation of an new sprinkler system.

WOMENS FELLOWSHIP ANNUAL REPORT 2014

This year 18 complete layettes and other miscellaneous items for the Newborns in Need program were put together. These were given to the Pregnancy Center. Four layettes were given to the Plateau Valley Resource Center.

One hundred health care packs were made and given to the Grand Junction Rescue Mission in addition miscellaneous toiletries which were also donated.

The Sunshine Committee sent out 55 "Get Well" or "Thinking of You" cards and 24 Sympathy cards.

The Food Bank needs were met, thanks to the community. At present 10 people are using the food bank. We received a generous donation from Marigold Market and from Albertsons.

Our annual coat giveaway is a much needed project for our community. Thanks to the Collbran Supply for providing space to display the coats. Thank you to those who donated coats, scarves, hats, and mittens.

There were 30 ladies from our community and the Grand Junction Congregational Church that attended the Women in Mission Luncheon. The program was the making of prayer bead bracelets.

Our main fundraiser, the annual Turkey Dinner, was a success. We served about 82 people. Thanks to hard work and generous donations we made approximately \$1000.00. Almond toffee was also sold at the event. Thank you to Sue Bellotti for making and donating candy. Albertsons also donated a turkey.

Womens Fellowhip made a donation of \$1500.00 to the church to help with heating expenses.

The flowerbed in the park was planted and cared for. It was beautiful.

Womens Fellowship assisted with one funeral dinner and paid for the food for the Maundy Thursday meal.

Womens Fellowship brought pens and pencils to be used for advertising for the Senor Tea, to be placed in the pews, and placed in the Rescue Mission packs.

CHRISTIAN EDUCATION - 2014

Sunday School has been in session for the children for 10 months of the year.

Average attendance is 5 with as many as 9 attending.

Edith Ann Power teaches the pre-kindergarten.

Sue Bellotti teaches those in grade school.

The children presented a special song at church on Dec. 21st. They enjoy singing for the congregation.

Following singing their favorite Bible songs and hearing the Bible story in the sanctuary, the children go to their classroom for crafts, games, puzzles, or playtime. This large group to small group concept has worked especially well.

Thank you for the donations of craft material provided by the congregation for Sunday School. We have kept our costs at a minimum by using materials and teaching materials from prior years.

We have doubled in size from 2013. What a blessing it is to work toward that goal for 2015.

PASTOR/PARISH RELATIONS COMMITTEE REPORT 2014

ARTICLE VII COMMITTEES

7.1.1 Pastoral/Parish Relations Committee: The task of the Pastoral/Parish Relations Committee shall be to provide an active, ongoing liaison between the pastor and the congregation. The Committee shall meet at least quarterly to provide counsel and guidance to the pastor and shall be a means of sharing relevant concerns of the parish with the pastor. The Committee shall organize and conduct an evaluation of the pastor every three (3) years. In most instances, the Committee will wish to meet with the pastor, but if deemed necessary, the Committee may choose to meet without the pastor. In such event, the pastor shall be informed of the meeting prior to the meeting and be informed immediately following the meeting of any pertinent concerns or action taken. This Committee shall consist of four (4) persons. Suggested Pastoral/Parish Relations Committee members include the immediate Past Moderator, the Past-past Moderator, a lay person from the congregation chosen by the Council, and a lay person from the congregation chosen by the pastor. Each person shall be appointed for a two-year term on an alternating basis so that two members shall retire each year. After serving one full term on the Pastor/Parish Relations Committee, each person shall be for one year ineligible for re-appointment to this committee, but is eligible to serve on other committees or in offices. This Committee will report recommendations to the Council.
