Collbran Congregational Church, UCC Annual Meeting Minutes January 21, 2018

Collbran Congregational Church, UCC Annual Meeting Minutes January 21, 2018. The meeting was called to order by Moderator Cindy Price at 1:15 pm, following a delicious selection of potluck dishes while visiting and enjoying time together.

Pastor Anne offered a prayer to start the meeting. We are thankful for our community of faith and our beautiful world. We are thankful for our church.

15 people were in attendance. 13 were members so a quorum was met (see attached sign in sheet).

Cindy asked folks to review and approve the agenda. Sylvia moved to accept the agenda and Sveto seconded. The motion passed and carried. The minutes from the 2016 year/ 2017 annual meeting were reviewed. They were approved at the February 2017 Council meeting.

Sue pointed out that Annie Anderson has been present at almost every meeting for a long time. We are sad that she could not be here for this one.

Clerk's Report: Monica presented the report for 2017. There was one correction. Lloyd Power should be added to the folks baptized. He was baptized on July 23, 2017. Monica noted that we now have 30 members.

Pastor's Report: Anne shared all the things she has been a part of for the past year. She said that she greatly appreciates having a Sunday off each month. She wanted us to know that she is willing to not take a weekend off during the upcoming Lenten season. She is having a good school year- easier than others have been, so she is willing to not take a Sunday off during Lent. She thanked everyone for their support. We thank Anne for her amazing energy and for her love for people and our church. We thank her and Sveto for all they do for our church.

Moderator's Report: Cindy gave her report. She said that it has been an exciting year for Church Council. She is thankful for everyone working together to tackle the problems that arise.

Treasurer's Report: Sue gave the Treasurer's Report. Sveto asked about the number in the year end balances. It was negative at the end of December but showed positive at the beginning of January. Sue said that the number is indeed positive. She reviewed the proposed budget for 2018. She explained the huge increase in the maintenance costs for the Parsonage. We have money in Savings from insurance for these repairs. The water bill cost has gone down since there is little use at the Parsonage. \$150 each is paid for taxes for the church and Parsonage. The Church and Parsonage are tax exempt but Sue has to fill out forms stating that and has to pay the \$150 each to file those forms. We also pay \$10 tax for Elna Hall's property that was donated to the church. Sue also pointed out that the Parsonage no longer has a phone.

Stewardship Report: Cyndi Leinberger gave the Stewardship Report. This committee sent out a letter, in the spring, to the church and community asking for contributions for all the different uses of our

church. \$3240 was received as a result of that letter. This money has been used to make many additional changes around the church.

Steward's Report: Jeannie gave the Stewards report. The Stewards do an amazing job in keeping things running smoothly at the church, for communion, for weekly services, and for special services. They also help line up help to provide food for fellowship time after services as well as special events. They order and purchase poinsettias for Christmas, lilies at Easter, and palms for Palm Sunday. Without them, things would not go well at all!

Trustee's Report: Julia and Cindy gave their report. The Trustees have been exceedingly busy this year in trying to keep up with all the unfortunate things that have occurred at the Parsonage or Church. More help is definitely needed. Julia, Cindy, Sue, and Nancy need a small army to help keep things running smoothly. They have undertaken all the work themselves with help from Sveto, Rory White, Becky Schowalter, and others. On this note, it should be added to the report that Sveto sealed the crack in the sidewalk on the northeast side of the church, to keep water from running down the wall there. It was agreed that the Trustees are definitely angels in disguise and we all thank them for their loving care of the Church and facilities.

Music Report: Sue gave the music report. Since we are down a pianist, she needs some help! We greatly appreciate Sue's beautiful music played for our church services and for coordinating the Christmas Recital.

Christian Education: Sue gave this report as well. She works so hard in so many aspects to keep our church viable. Thank you Sue! She said that we definitely need more kids and more helpers.

Women's Fellowship: Nancy gave the Fellowship report. She thanked everyone for donations made for all of their projects. She mentioned that they will ask Sue to take money from their account and add it to the church's account so that it can gain interest.

Pastor/Parish Relations: Cindy noted that there was no activity in this committee in 2017. Edith Ann Power has been the Pastor's representative but will not be able to continue that. Overall, the church and community are happy with how things are going but it would be good to continue this committee. Memorial Committee: Cindy and Nancy gave this report.

A motion was requested for the approval of all the reports for the 2017 church year. Sveto moved to accept all the reports with the correction to the December final balance. Jean seconded the motion and it passed and carried.

Nominating Committee: The nominations for offices were reviewed. A variance will have to be made to our by-laws because the Christian Education position is supposed to have a 2 year term. Sue will take that position again. Many other positions are beyond the term limits. Peggy Shiflet will take over for Edith Ann Power as a Steward, for the 2nd year of the term. Jeannie Reeves and Sylvia Spangler will continue as Stewards. Cindy and Julia will take another term as Trustees. Jean moved to over-ride the term limits to allow people to fill the positions. Jim Cole seconded. The motion passed and carried. Sveto moved to accept the slate of nominees. Jean seconded. The motion passed and carried.

The slate of officers is: Moderator- Julia Cox, Moderator Elect- Sylvia Spangler, Past Moderator: Cindy Price; Clerk- Monica Klingler, Treasurer- Sue Bellotti, Stewards- Jean Kees, Jeannie Reeves, Sylvia Spangler, Peggy Shiflet; Trustees- Cindy Price, Nancy Karlson, Sue Bellotti; Julia Cox; Christian Education-

Sue Bellotti and Shannon Murphy/Julia Cox, Musical Director- Sue Bellotti. Pastor Parish Relations- Cindy Price and Sylvia Spangler. Memorial Committee- Nancy Karlson and Cindy Price.

Old Business: None

New Business: Cindy Price discussed concerns about the Parsonage. The foundation was repaired. Now we need to get bids for repair of the water soaked walls and floors. Randy Hall, Pete Kenney, and others are potential bidders. It was pointed out that none of the local folks are licensed or bonded. Sue thought that it would be best to have someone who is licensed and bonded. After repairs are made to the parsonage, we will consider selling the building. This will need to be discussed with and voted on by the church members. Another meeting will be convened to make this decision. Sylvia thinks that since we have put so much money and time into the parsonage for repairs and upkeep, the only way to recoup the money will be to sell it. Lloyd feels half-opposed since it will be difficult to ever have another parsonage. Other thought was that renting would not be a viable option for a future pastor. We will not likely be able to hire a full-time pastor again. It was noted that The Assembly of God church also had to give up their Parsonage. It is tough for all churches.

There was no further business.

CLERK'S REPORT 2018

- An average of <u>20</u> people attended church each week, during the past year.
- Many friends went to be with our Lord, this year, from our church and community. CHURCH ACTIVITIES:

We are so thankful that Pastor Anne Djokic continues to serve our church and that Sveto fills in for numerous odd jobs as assistant to the Pastor¹. We are all thankful for the time Anne contributes, throughout each week, to visit with members and their families or with anyone else who requests her presence. This is in addition to her full-time job teaching school at Clifton Elementary.

- Sveto Djokic has completed much-needed work around the church yard, making it look so much better and Norm McCallister has painted and made repairs on the porches and the welcome sign in front of the church, making them look much nicer. Thank you both for all you do!
- Sue Bellotti and Cindy Price continue putting together the monthly "Mustard Seed" to send out news about our church to those who cannot attend and as a reminder of upcoming activities for everyone. Thank you both for your ongoing work!
- Collbran Congregational Church held another fun Vacation Bible School June 27-29 (thanks to Sue Bellotti for organizing it and to many others for making it happen!). 34 children and 25 volunteers attended the three days of activity and fun. On the Sunday following VBS, the service featured the kids and what they learned.
- The Children's Sunday School students have learned many good things from the Bible this past year and have sung for the congregation several times. Sue Bellotti continues to lead the students in learning about Jesus. 3-5 children have regularly attended during the past year.
- The Adult Bible Study met and learned more of our God through several studies this year. Pastor Anne led those programs. 1-4 people attended.
- Women's Fellowship hosted the annual Senior Tea on May 1st. 23 students and their families from Plateau Valley High School, 15 students from Grand Mesa High School, as well as Gov Aker of the Job Corps and superintendant Mike Page from the Plateau Valley schools attended and had a very good time. Many thanks to Pastor Anne, to all the work that the Women's Fellowship did in preparation, and thanks to Magician Dave Wallin. This continues to be a good outreach to area families.
- Women's Fellowship prepared and provided for many memorial services, for the Maundy Thursday Sedar supper, for Church potlucks and gatherings, for many mission projects, for the annual luncheon with Grand Junction UCC, and for the Turkey Dinner. Their contributions to the community may not always be noticed but are invaluable and make people feel loved.

- Our church hosted the annual Christmas Recital on December 2nd. Many children and numerous adults provided beautiful music and readings to remind everyone about the most important reason that we celebrate Christmas -God's amazing love for us.
- Our Church continues to be available for community activities such as gymnastics and dance classes, basketball, children's activities, 4H meetings, Gray Gourmet, Lion's Club meetings, family parties and gettogether's. Many community members use our church each year.
- The Trustees worked very hard to keep up with the maintenance and repair of our church and parsonage. After making repairs to damage at the parsonage, the church voted at a Special Called Church Meeting on April 15, 2018, to put the Parsonage up for sale. This was a bittersweet decision but due to huge expenses in upkeep and due to it not being used regularly, this decision was voted on and passed in favor of sale. The Parsonage was sold in June to some very good people. It will be a relief to the Trustees to only have to worry about upkeep on the church now. Many thanks are given to Julia Cox, Cindy Price, and Sue Bellotti for all the work they have done and continue to do, to keep our facilities in good condition.

Nancy Karlson also tirelessly continues to help and give input too, as a trustee.

- Delbert Koehn helps keep the lawn mowed and diligently shovels snow each winter. He is a tireless and conscientious worker.

The duties of the Moderator shall be to preside at all Church Council meetings and all business meetings of the congregation. The moderator shall be a member of the church. The Moderator shall be elected for a term of one year.

TREASURER'S REPORT 2019

The Treasurer shall be a member of the church and will receive all monies of the church, and, upon request, give quarterly receipt for same. He/she shall deposit funds received in such depository as the Church Council shall order and shall disburse the same with the recommendation of the Board of Trustees and under the direction of the Church Council. He/she shall manage and be responsible for the investments under the direction of the Church Council. The Treasurer will maintain a review of the budget standings and notify the Trustees in the event of a looming budget shortfall.

The Collbran Congregational Church, UCC, successfully met the bills, salary, and maintenance expenses for 2018.

As with 2017, additional expenses were incurred with larger repairs and maintenance projects at the church and parsonage. Maintaining this large structure is a great financial responsibility.

The sale of the parsonage at 803 Wagonwheel Ct. Collbran, brought \$205,000.00. After fees and expenses the balance of \$200,350.50 was transferred to the UCFunds investment account bringing the total, as of Dec. 31, 2018, to \$247,168.59. The United Church Funds are protected in savings to assure longevity of the life and mission of Collbran Congregational Church, United Church of Christ

The UC Funds Investment Account has done very well this year with the Stock Market as aggressive as it has been. We ended 2018 with the balance of \$247,168.59. Growth in the account is at \$11,929.81 for the year.

We will continue to be prudent with the management of the funds received from each of you who so generously and consistently support this church. In-kind donations continue to help keep our spending in check for everything from office and cleaning supplies, paper products, and crafts for the children. Please include your receipt with any purchase you make for the church and I will be able to apply your gift to your giving balance.

I thank each of you for your financial support and your time and energy spent supporting this church building and family. It is the people who make the church.

NOISY OFFERING was started in our church in 2004 by Rev. Faye Gallegos, based on the scripture in Mark 12:41-44.

41, And Jesus sat over against the treasury, and beheld how the people cast money into the treasury: and many that were rich cast in much.

42, And there came a certain poor widow, and she threw in two mites, which make a farthing.

43, And he called unto him his disciples, and saith unto them, Verily I say unto you, That this poor widow hath cast more in, than all they which have cast into the treasury:

Later in the service each week, we have the opportunity to "give as we can", as noted by Paul as he instructed the followers in Corinth:

1 Corinthians 15:2

Upon the first day of the week let every one of you lay by him in store, as God hath prospered him, that there be no gatherings when I come.

2018 ANNUAL REPORT: TRUSTEES

Under the direction of the Church Council and, except as otherwise provided, the trustees shall have the care and custody of the property of the church as a Sacred Trust, whether real or personal, in accordance with the provisions of the Constitution and Bylaws.

It is the responsibility of the Board of Trustees to review and keep current the insurance on all the properties of the church. In the event of a looming budget shortfall, the Board of Trustees will work closely with the Treasurer and the Stewardship Chairperson in making recommendations to the Church Council.

The Board of Trustees shall each fall, before the Annual Meeting, participate in preparing a budget for the ensuing year. The Board of Trustees shall consist of four persons.

Trustees attended to upkeep and repair issues with the parsonage, church and grounds issues throughout the year.

Many thanks to Sveto Djokic, Norm McCallister, Bret Murphy, Tom Cox, Tom Bieser, Rory White, and Larry Bellotti for their great help in completing tasks which included, in part, the following:

Removing and disposing of the defunct dishwashers from the church kitchen, disconnecting and moving the large stove so the flooring could be replaced, then moving it back. (The old linoleum was curling at the edges creating sanitation and safety threats.)

Leaks from water pipes in the kitchen were addressed as well as water leaking into the kitchen from the drainage in the west lawn area especially during heavy rains, winds, and snow/ice melt. Rory White assists with water leaks. Tom Bieser blows out the lawn sprinkling system before the first freeze.

Fill dirt was hauled to the west lawn which was graded from the building, replacing dirt that washed away over the years from sprinkling and eve water falling on it. The eve was secured once again, and engineering of the roof drainage system (eves) was questioned and plotted. Thanks to Delbert Koehn for a great job keeping snow and ice cleared from the walk ways during the winter, and the lawns mowed during the summer.

Sveto continued to treat sprouting tree growth against the church foundation and pruned hedges and bushes.

Norm McCallister restored the church sign with paint, new Plexiglas, and lighting and refreshed the paint on the entry porch.

Norm and Sveto installed a portable handicap ramp from the sanctuary to the overflow room.

The lawn sprinkling system requires continual upkeep and a water leak was repaired at the connection to the Town water in Mothers' Park. Thanks to Kent Hill for donating the dirt work, chain link fence access and repair.

PASTORAL/ PARISH RELATIONS COMMITTEE REPORT
